





## Broker registration terms and conditions

Please read these terms and conditions carefully before agreeing to enter into the Prize Draw.

- ModaMortgages is a trading name of Chetwood Financial Limited, a company registered in England and Wales under company number 09964966 and whose registered office is at Ellice Way, Wrexham Technology Park, Wrexham, Wales, LL13 7YT. CHL Mortgages is used under licence by CHL Mortgages for Intermediaries Limited. Registered office: Admiral House, Harlington Way, Fleet, Hampshire, United Kingdom, GU51 4YA (Company No 12954007). ('Chetwood', or 'we') will be conducting a Prize Draw ('Prize Draw') online these terms and conditions ('the Terms and Conditions') set out the basis on which we'll conduct the Prize Draw.
